7. Lift Assist Fee Follow Up

- a. On June 8, 2023, Interim FC Haverty brought an item to the Board about exploring a lift assist fee when we respond to for-profit care facilities for patient assistance requests
- b. The July 27th adopted fee schedule Ordinance 2023-02 included this fee structure (recovery of actual costs) and allows us to continue to explore implementation.
- c. There are a number of items to consider when we look at this fee, many of which the Board discussed back in June (ensuring its use was limited to for-profit healthcare facilities, what is the legal definition and required training level of a healthcare facility that calls, etc.).

- Notably, the data from 2022 initially indicates that 95 calls out of 3298 (2.8%) occurred in a healthcare facility. Also notable, a vast majority (1262, or 38%) of the calls occurred in one- and two-family residences.
- e. Staff will continue to look into it further and come back with a recommendation in the future.

OPERATIONS REPORT – (AC Greene)

Air Operations Update:

This evening I will walk you through the events that have occurred over the past 10 days in Air Operations. Our goal remains 100% transparency with the event and process to bring Air Operations back into service. This report will focus on a high-level overview, as a Green Sheet is pending distribution which will highlight the details of the situation.

On Tuesday October 3, 2023, Copter 1 had completed training operations over Folsom Lake and was returning to Station 115 when its crew door departed the helicopter in flight over Granite Bay. The door struck the roof of a house, causing minimal damage. The door was located and positive contact made with the homeowner. There we no injuries to our flight crew or the public. Air Operations immediately moved into a Safety Stand-Down and remains in this mode until further notice. Over the past week the Support Services Branch has worked diligently with the homeowner to repair the roof.

The Operations Branch solicited assistance from the CalFire Aviation Management Unit to collect the facts of the event and provide recommendations to move forward with the process. This took several days for them to complete, and their partnership in firefighting aviation is to be commended.

The Executive Team and all Assistant Chief's met with the Air Operations Division on Wednesday October 11 to review the event and facts that have been determined at this time. The specific details as to the event and contributing factors will be released in Green Sheet format by the end of this week to ensure our transparency. We are currently putting a plan together to address the repairs of Copter 1 and any modifications that may be necessary for Copter 2. We look forward to communicating this plan once complete.

Civil Unrest Potential Relating to Current Events in Israel

On 11 October 2023, a video circulating on multiple social media platforms shows former Hamas leader calling for action. It is reported to call for Muslims to engage in violent action, specifically for Muslims in the nations surrounding Israel to enter the war on Hamas' behalf on Friday, 13 October 2023.

The District receives communications directly from the Central California Intelligence Center, who is not aware of any specific or credible threat to the Eastern District of California at this time. Our priority remains to ensure the safety of our members and uninterrupted service delivery. We work closely with local law enforcement and follow our civil unrest operational plans on a case-by-case basis.

BACKGROUND

On January 12, 2023, the Sacramento Metropolitan Fire District's (District) Board of Directors approved Resolution 2023-004 declaring certain real property (Property), located on Oak Avenue in Orangevale (APNs 213-0014-038 and 213-0014-039), as surplus property and authorizing the initiation of the disposition process. The District completed the Notice of Availability process in accordance with the Surplus Land Act procedures and subsequently retained a real estate broker to list the Property in the Multiple Listing Service with a listing price of \$475,000.

DISCUSSION

One offer for the property was received in August 2023, and the District began negotiations with the offeror on the terms of the sale. This offer was eventually cancelled by the offeror. Subsequently, a second offer was received from a different party in September 2023 and the District began negotiations on the terms of the sale. The offeror has accepted the terms of the District's counter offer and the offer is outlined as follows:

Although the offer received is below the listing price, Staff believes that accepting the offer is in the best interest of the District in consideration of current market conditions and the unique characteristics of the Property.

FISCAL IMPACT

The District will receive the proceeds from the sale of the Property less the broker's commission (5%) and the closing costs.

RECOMMENDATION

Staff recommends that the Board adopt the Resolution to authorize the Fire Chief or his designee to affect the sale of the Property to the offeror.

SUBJECT: Purchase Approval – DOT System Decontamination Bags for Contaminated Turnout Gear

TOPIC

Staff requests Board approval for the purchase of DOT System Decontamination Bags from Thin Red Line Decon. These bags would be issued to all members of the line in accordance with best practices for exposure reduction and cancer mitigation.

BACKGROUND -OR- SUMMARY

The Safety Division in collaboration with Operations and Labor is continuing its exposure mitigation efforts within the District. The first step was building out the Care and Maintenance center, followed by the Battalion Based Cleaning Program. The next step was introducing the Storm Stick, a device that connects to an engine's discharge outlet and uses aerated water and specialized soap to decontaminate turnouts, SCBA packs, and masks after fires and prior to crew members entering the cab of the apparatus. We are now in the process of further facilitating the clean cab concept by addressing the way in which personal protective equipment (PPE) is transported back to the station and then to the Safety Division for further cleaning/decontamination. The culmination of these steps will dramatically result in less exposure to our members to carcinogens and other toxic substances.

DISCUSSION

The Safety Division is requesting authorization for the purchase of the decontamination bags for contaminated PPE for all members of the line. These bags are designed and tested to effectively seal in all carcinogens, including but not limited to Polycyclic aromatic hydrocarbons (PAHs) and Volatile Organic Compounds (VOCs). The contamination control bags are washable and reusable and serve as another layer in the Safety Division's comprehensive cancer mitigation efforts.

The DOT System Decontamination Bags have unique design/performance specifications and quality requirements that are currently unavailable in comparable products. The product has a proprietary design that allows for encapsulations of carcinogens within the bag. Other bags were purchased for review, but upon their arrival, it was discovered they did not have the required encapsulation properties, resulting in no further evaluation. DOT System Decontamination Bags are made in Sweden and the manufacturer has confirmed that Thin Red Line Decon is currently the only company in the United States that purchases and delivers these bags to fire departments domestically. Additionally, the vendor has provided the District with a scientifically backed assessment of the control bag's ability to eliminate PAH/VOC contamination due to the bag's design.



FISCAL IMPACT

The proposed cost for control bags for all line members is \$190,000.00. This cost is included in the District's FY 2023/24 Final Budget.

RECOMMENDATION

Staff recommends that the Board authorize the purchase of DOT System Decontamination Bags from Thin Red Line Decon.







Injury Severity by Firework Type





Annual Property Loss






Vegetation Fires < 1 Acre


3 Year Vegetation Fires > 1 Acre Total Loss 40 Acres

 - Fire Marshal, Deputy Fire Marshal, 2 Supervising Fire Inspectors, 4 Fire Investigators, 6 Fire Inspectors (14 personnel)
 - July 04 15:00 01:00 (2 public displays)
 - Fire Marshal, Deputy Fire Marshal, 2 Supervising Fire Inspectors, 3 Fire Investigators, 5 Fire Inspectors, 4 Fire Inspector Trainees (16 personnel)

Metro Fire CRRD Outcomes July 01-05

- Referred 5 incidents to Code Enforcement
- Assisted ATF with sting operation
- 23 fire incident responses
- July 3 confiscated 30-40 pounds of illegal fireworks
- July 4 confiscated estimated 2,000 -2,500 pounds illegal fireworks
 - Required Metro Fire logistics box truck to transport product to EOD
 - Largest single haul in the region!



Metro Fire Challenges

- Difficult to pinpoint source of fireworks
 - Large crowds assembled in courts and middle of the road
 - Boom and crackle of fireworks happens in seconds
 - Sound carries quite some distance
 - Catching someone in the act <u>is not</u> an easy task
 - Night conditions not conducive to video/photography
- Widespread instances of people gathering at schools and community parks to launch fireworks
- Primary and secondary response routes overwhelmed
 - Improper use of safe and sane fireworks on make-shift aerial platforms in roadway
 - People launching illegal fireworks in roadway
 - People unwilling to let personnel through
- Personnel safety
 - Fire Inspectors are not peace officers, and they are unarmed
 - Large gatherings of unruly, intoxicated individuals
 - Hurling fireworks at response vehicles and responders
- Indifference to Authority





- Sacramento County Code Enforcement Advisory letters in advance of New Years Eve, and earlier in 2024
- Explore opportunities to pair law enforcement officer with fire inspector, or respond in tandem to incidents to ensure personnel safety
- SSD expanding use of drones to support host liability ordinance
- Advocate for legislation at the State and/or Federal level to address the availability of fireworks that are illegal in California
- Sacramento County Hosts Liability exploring enhanced fines for discharge of fireworks on school and community park property
- Stronger emphasis on appropriate use and disposal of safe and sane fireworks
- Sacramento County exploring narrowing the window for fireworks sales
 - June 29 July 04
